

#### ASEAN HEALTH CLEARANCE REQUIREMENTS FOR ENTRY INTO SINGAPORE

#### Important information for our patients

#### **Health Clearance Requirements**

From 12 midnight on Monday 16 March 2020, all ASEAN nationals seeking to make a short-term visit to Singapore must seek a formal Health Clearance. To enable this, patients must submit mandatory information about their health condition in order to seek clearance before their intended date of travel into Singapore.

ASEAN nationals from the following countries must seek approval: Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Malaysia, Myanmar, Philippines, Thailand and Vietnam.

All Icon patients must ensure that their applications have been approved by Singapore's Ministry of Health (MOH) before they travel to Singapore.

Approved applications will be verified by Immigration and Checkpoints Authority (ICA) officers at Singapore airport. Short-term visitors who arrive without the following will be denied entry into Singapore:

- The necessary approval from Singapore's MOH
- Proof of the place where they will serve the 14-day Stay-Home Notice (SHN)
- Ability to meet all prevailing entry requirements

All nationals of ASEAN countries are advised to obtain the approved health clearance from the Singapore's MOH before making their travel bookings.

A step by set guide to applying for clearance and the arrival process is available below.

- The processing time for all applications is between 14 21 days
- The outcome of the application will be sent to the email address provided
- Please ensure you have a copy of the approval for verification at the Singapore checkpoints
- Only one application per traveller will be processed at any one time
- Please submit a new application if there are changes to any of the items in the Health Clearance Form that has been submitted or approved. The most current application will be treated as a new application, with only the most current application processed
- Approvals are valid for 14 days from date of approval

#### **Step 4 Obtain proof of accommodation**

Patients and caregivers will have to declare a place of residence in Singapore and provide proof of this on entry.

- For hotel or rented accommodation, bookings must cover the entire period of the stay (minimum of 14 days)
- If staying at your own place of residence or that of family member/friend, please provide a copy of an official document stating the address (i.e. photocopy of NRIC).

Please note that proof of accommodation must be in the name of the patient or caregiver (part of the travelling party into Singapore).

#### Step 5 Patient arrives at Singapore/Icon clinic

#### **Important Information on Arrival in Singapore**

All short-term visitors entering Singapore who have travelled to the following countries within the last 14 days will be issued a 14-day Stay-Home Notice (SHN):

- ASEAN countries
- Japan
- Switzerland
- United Kingdom

This is effective from 12 midnight Monday 16 March 2020

Short-term visitors who will be put on SHN must provide proof of the place where they will serve the 14-days, for example a hotel booking covering the entire period or a place of residence that they or their family members own.

# COVID-19 Health Clearance Form

5 mins estimated time to complete

From 16 March 2020, 2359 hours, all short-term visitors who are nationals of any ASEAN country\* must submit health information for clearance by Singapore's Ministry of Health before their intended date of travel. Approved applications will be veri ed by the Immigration and Checkpoints Authority at the Singapore checkpoints. Visitors without the necessary approval, or proof of the place where they will serve the 14-day Stay-Home Notice, or do not meet prevailing entry requirements, will be denied entry.

#### Important Information for Applicants:

- The processing time for all applications is between 14 21 days.
- The outcome of the application will be sent to the email address provided.
- Please ensure you have a copy of the approval for veri cation at the Singapore checkpoints.
- Only one application per traveller will be processed at any one time.
- Please submit a new application if there are changes to any of the items in the Health Clearance Form that has been submitted / approved. The most current application will be treated as a new application and only the most current application will be processed.
- Approvals are valid for 14 days from date of approval.

#### Important Information on Arrival in Singapore:

- All travellers entering Singapore who have travelled to the following countries within the last 14 days will be issued a 14-day Stay-Home Notice (SHN)<sup>2</sup>:
- ASEAN countries, Japan, Switzerland, and the United Kingdom (List as of: 16 March 2020)
- Travellers who will be put on SHN must provide proof of the place where they will serve the 14-day SHN, for example a hotel booking covering the entire period, or a place of residence that they or their family members own.



\*ASEAN countries besides Singapore: Brunei Darussalam, Cambodia, Indonesia, Lao PDR, Malaysia, Myanmar, Philippines, Thailand, Vietnam.

^The SHN will not apply to travellers transiting in Singapore without leaving the transit area.


